AutoRama is February 15-17 at Dallas Market Hall. Jim Crossland is in charge of arrangements and cars representing the Club. The Club will pay entry fees.

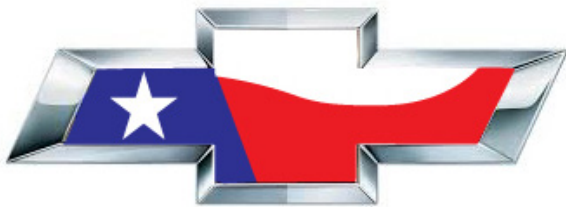
